9 Report of Town Clerk, Disqualification of Town Councillor

The Town Clerk presented a Report and information Guidelines from N.A.L.C., detailing the position when a Councillor fails to attend a meeting of the Town Council or any sub-committee meeting thereof for a period of six consecutive meetings (months) and no Apologies submitted or absence approved. Therefore the person ceases to be eligible to be a serving Member of the Council.

Subsequently, Town Council attendance records show that Mrs. R. Meadows last attended a meeting recorded in September 2013 and therefore six meetings have been missed, without any apologies being submitted.

Hence a disqualification of office will apply and Mrs. Meadows can no longer continue in the office of Town Councillor.
