

**MINUTES OF THE HETTON TOWN COUNCIL MEETING HELD  
ON MONDAY 18<sup>th</sup> NOVEMBER, 2013 IN THE COUNCIL  
CHAMBERS, THE HETTON CENTRE AT 7.15 p.m.**

1. Apologies for Absence

Apologies for absence were received from Councillors Mrs. Adamson, Mrs. J. Blackburn, Mrs. J. Heron, R. Heron, Maddison, Nairns, Tate, Wilkinson (8)

Prior to the commencement of the Meeting Sgt. A. Taylor and P. C. Jeff Hudson of Hetton Community Police Team, Northumbria Police met informally with Councillors to discuss and highlight issues of concern and initiatives in the area. Several matters were highlighted, in particular, Councillor Maddison, with support from Councillor Storey, raised with concern the problem of Caravans being parked on the highways in all locations, often in front of neighbours properties. Sgt Taylor stated the only legislation which could be used related to congestion on a highway whereby emergency vehicles could not gain access if necessary.

Councillor Robson highlighted the ongoing issue of youths in gangs congregating and consuming alcohol at Hetton Lyons Country Park, particularly on weekend evening. He suggested the retailer supplying the youngsters with alcohol should be prosecuted.

Councillor Glover highlighted the problem of double parking in Regent Street causing congestion and difficulty for buses en route.

Councillor Mrs. Anderson asked what were the Police priorities in the area.

Sgt. Taylor responded that there had been a considerable reduction in general crime and disorder. However focus was now on reduction of domestic violence and youth disorder.

The Mayor thanked the officers for their time and information.
