

**MINUTES OF THE HETTON TOWN COUNCIL MEETING HELD

**5 Reports from Members – Ward matters to be investigated:-**

Cllr Tate reported the ongoing problem of riders of Quad bikes riding on highway and off road in the area of Coalbank Square – this causing great nuisance to residents, perhaps Gentoos should be advised to investigate.

Cllr Mrs Heron asked if an Officer from Co. Durham Community Foundation could be invited to meet with members to brief them on funding opportunities.

Cllr R. Heron also highlighted similar Quad bike nuisance problems in the Hetton Downs area. He also suggested that the Northumbria Police Community Inspector be invited to meet with HTC.

Cllr Wallace reported that he had attended the recent P.A.C.T. meeting at Hetton Workingmen's Club, where only he had attended and had received the following statistics gathered by Northumbria Police for the recent summer months in Hetton area:-

3 shop thefts 1 burglary 3 bike thefts 1 car theft 4 various  
And 22 reports of youth disorder which were down from 29 in previous reported quarter.

Cllr Todd reported, again, issue of increase of dog fouling on highway and verges. He asked if the City Council Environment Officer could post advisory notices and enforcement in the area.

Cllr Glover reported a blocked gully at rear of 23/25 Houghton Road which caused recent flooding problems on the highway.

Following site meetings concerning Hetton Burn, the Quay issues. Members noted and accepted the report.
